**Step 1** - Session Fees and Norris Membership (if Renewed in August SCST Families will receive a 10 % discount) will be paid at the front desk of the Norris Rec. Center. Renewal Forms can be found on the SCST Website ([www.stcswim.com](http://www.stcswim.com)) or at the Norris Front Desk. Once Session and Membership Fees are paid in full you will receive a Customer Identification number. (This number will be used in the on-line process to verify that these fees are paid)

**DO NOT PROCEED TO STEP 2 UNTIL STEP 1 IS COMPLETE!**

**Step 2** – Go to the SCST website ([www.stcswim.com](http://www.stcswim.com)) and use the *Registration Link*. Once you are in the SCST Registration site you will need to complete the process and pay the Swimmer fees, ISI Fee, Electronic Fee and any unpaid fees. Once, this has been completed you will receive an email confirmation and your swimmer is now ready to begin practice.
